Potable water and Firewood are available on site. Haul out your own trash. Dogs are permitted. “Tin-Tepees” and modern camp area will be available.

**! At this time No Fee will be charged !**

The encampment is being held on private property. Only your respect of the land and fellow attendees will keep it so. A \$5 per tent donation is asked for to help pay for the “necessities”.

This is the first time a Colonial only time period Encampment is available in the southwest United States.

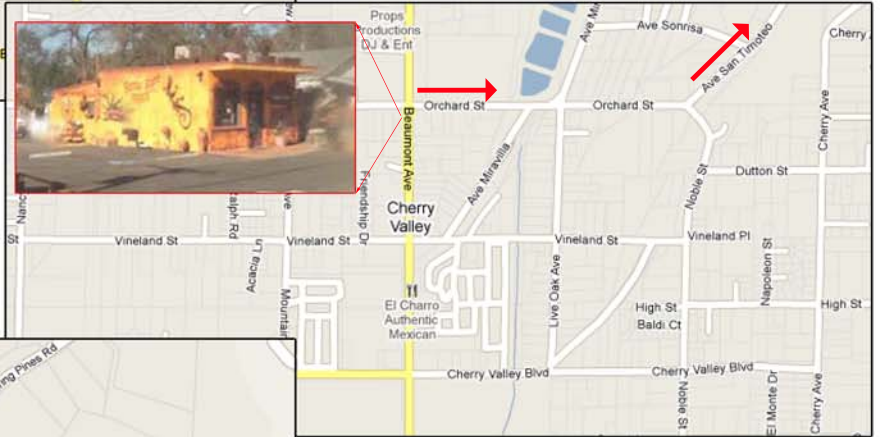

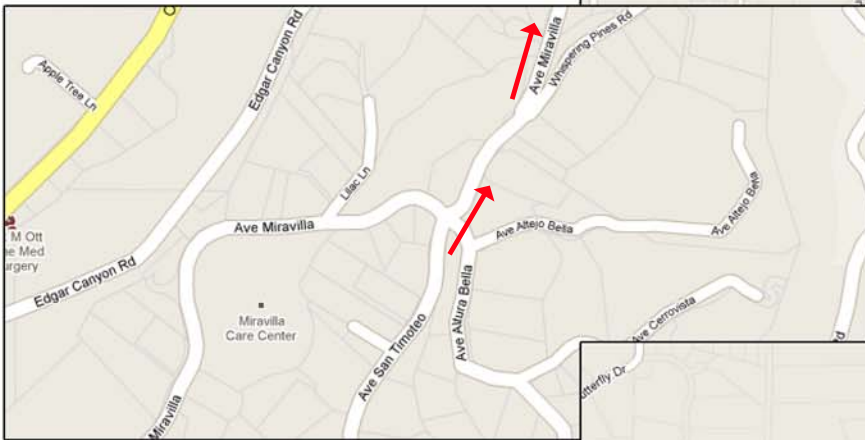


From the 10/60 Fwy in Beaumont

Head **NORTH** on Beaumont Ave

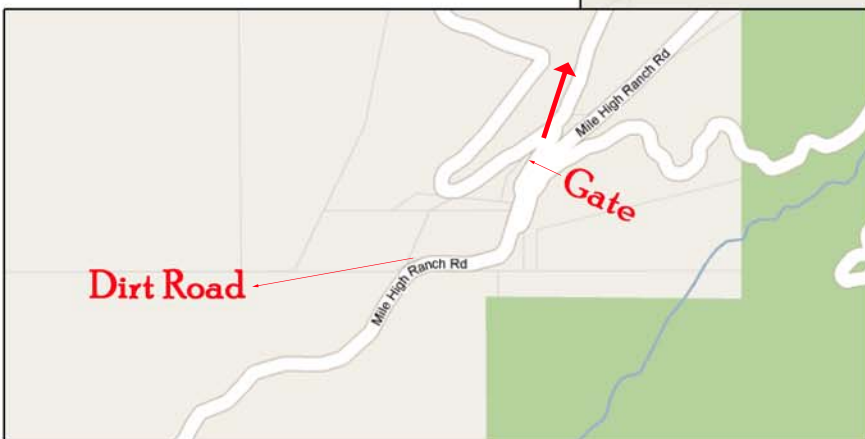
Look for "Retro Red's Depot" on left

Turn **LEFT** at Ave San Timoteo



Continue on Ave San Timoteo  
Go **Straight** onto Ave Miravilla  
Stay **LEFT** on Miravilla at fork



Continue on Ave San Timoteo  
for approx. 7 miles  
It turns into Mile High Rd



Mile High Rd turns **RIGHT** into dirt  
Follow dirt road to the **LEFT**  
Enter gate and stay **LEFT**

**WAIVER AND RELEASE AGREEMENT**

Please read carefully before signing

This is a release of liability and waiver of certain legal rights

In consideration for my being permitted to participate in the activities of The Grand Colonial Faire, I agree to the following Waiver and Release:

I acknowledge that the faire and shooting has inherent risks, hazards, and dangers for anyone, that cannot be eliminated, particularly in a wilderness environment. I UNDERSTAND THAT THESE RISKS, HAZARDS, AND DANGERS INCLUDE WITHOUT LIMITATION:

1. The risk of handling firearms and being near others that have firearms in their possession;
2. The risk of injury from ammunition and shot from other guns;
3. Walking in rugged country, including encounters with wildlife, animals and insects;
4. Inclement weather conditions;

I understand the risks, hazards, and dangers of shooting and have had the opportunity to discuss them with the Faire organizers. I understand that these activities may require good physical conditioning and knowledge necessary for me to engage in these activities safely. I understand that I have responsibilities. My participation in this activity is purely voluntary. No one is forcing me to participate and I elect to participate in spite of the risks. I acknowledge that I am responsible, as the parent or guardian, for the conduct and the safety of my children. I AM VOLUNTARILY PARTICIPATING IN ALL ACTIVITIES OF THE FAIRE WITH FULL KNOWLEDGE OF THE INHERENT RISKS, HAZARDS, AND DANGERS INVOLVED AND HEREBY ASSUME AND ACCEPT ANY AND ALL RISKS OF INJURY, PARALYSIS, OR DEATH.

Lastly, I, for myself, my heirs, successors, executors, and subrogates, hereby KNOWINGLY AND INTENTIONALLY WAIVE, AND RELEASE, INDEMNIFY AND HOLD HARMLESS ALL MEMBERS OF MORGAN'S RIFLE COMPANY AND THE PROPERTY OWNERS OF MILE HIGH RANCH, their directors, officers, agents, employees, and volunteers from and against any and all claims, actions, causes of action, liabilities, suits, expenses (including reasonable attorneys' fees) which are related to, arise out of, or are in any way connected with me or my children's participation in this activity including, but not limited to, NEGLIGENCE of any kind or nature, whether foreseen or unforeseen, arising directly or indirectly out of any damage, loss, injury, paralysis, or death to me, my children, or my property as a result of my engaging in these activities or the use of these services, animals, or equipment, whether such damage, loss, injury, paralysis, or death results from the negligence of all activities or persons or from some other cause. I, for myself, my heirs, my successors, executors, and subrogates, further agree not to sue or make any other claim as a result of any injury, paralysis, or death suffered in connection with my use and participation in the activities of THE GRAND COLONIAL FAIRE.
